

Website Terms of Use - LET'S REVAMP

The LET'S REVAMP (Referred to as "LR" in this document) Website is owned and operated by Kornerstone Development Pty Ltd. LR is an Australian business name and licensed to Kornerstone Development Pty Ltd. The meaning given to certain words used in these Terms are contained in the "Definitions" section below.

Acceptance of Terms
